The Dearborn Figure Skating Club will host this annual synchronized skating competition at the Dearborn Ice Skating Center on Saturday March 29, 2003. This competition is sanctioned by the U.S.F.S.A. and will be conducted in accordance with the rules set forth in the 2002 – 2003 edition of the USFSA Handbook. Skate Canada sanction is pending.

Applications: All applications must be postmarked no later than February 14, 2003. Each team must submit a typed list of all (including alternate) team members name, birth date and U.S.F.S.A. membership number. Please use the attached sheet. Mail completed applications to:

Fees: The entry fee is \$75.00 per team plus \$15.00 per competitor, including alternates. All fees are due when applications are submitted and must be payable in U.S. Dollars only. Please make checks payable to: Dearborn Figure Skating Club.

Awards: Awards will be made on a basis of final placement. All team members of teams placing first through fourth will be awarded medals. All competitors will receive participation awards that do not place. An elimination round may be held in accordance with U.S.F.S.A. guidelines.

Practice Ice: The Dearborn Ice Skating Center is a multiple-surfaced facility with two rinks that each measure 85' x 200'. Practice ice segments will be available on Friday March 28, 2003 based on availability. This will be on a first-come, first-served basis using the attached practice ice form. The fee will be \$70.00 per 15-minute segment. All teams will be able to skate their entire program on the warm-up rink prior to initially skating their competitive program.

Music: All teams must submit two (2) tapes/CD's of each program they will be skating. If practice ice is being purchased, an additional tape or CD for that session is required. Tapes/CD's will be turned in at registration.

Registration: The registration desk will be located in the lobby of the Dearborn Ice Skating Center. A coach, or other team representative must register and pick up their team packet. Tapes/CD's should be turned in at this time.

Program photos: Team photos may be submitted along with the team roster for inclusion in the competition program.

Food: Multiple concession areas will be open during the day of the event. A listing of local restaurants will be available at the registration table.

Video Taping: Ledin Photography will videotape and digitally photograph this competition.

Admission: There will be an admission fee of \$3.00 for spectators. Children under 5 are free.

Parking: Ample free parking is available on site.

Events / Divisions

Preliminary: a team of 8 – 16 skaters. At least 75% of the team must be 9 years old or younger on July 1. Up to 25% of the team may be 11 years old or younger on July 1. (Skating Time: 2 minutes)

Youth Introductory: a team of 8 – 12 skaters. The majority of the team must be 11 years of age or younger on July 1. (Skating time: 2 minutes)

Teen Introductory: a team of 8 – 12 skaters. The majority of the team must be 18 years of age or younger on July 1. (Skating time: 2 ½ minutes)

Juvenile: a team of 12 – 20 skaters. Skaters must be 11 years of age or younger on July 1. (Skating time: 3 minutes)

Intermediate: a team of 12 – 20 skaters. Skaters must be 15 years of age or younger on July 1. There can be no crossovers to novice, junior or senior teams. (Skating time: 3 ½ minutes)

Novice: a team of 12 – 20 skaters. Skaters must be 14 years of age or younger on July 1. (Skating time: 3 ½ minutes)

Junior Classic: a team of 12 – 20 skaters. 75% must be 18 years of age or younger on July 1, and the remaining 25% may be 19 years of age or older. There can be no crossovers to junior or senior teams. (Skating time: 4 minutes)

Junior: a team of 12 – 20 skaters. Skaters must have reached the age of 12 and must not have reached the age of 19 on July 1.

Short Program (Skating time: 2 minutes 40 seconds)

Free Skating Program (Skating time: 4 minutes)

Senior: a team of 12 – 20 skaters. Skaters must have reached the age of 12 on July 1.

Short Program (Skating time: 2 minutes 40 seconds)

Free Skating Program (Skating time: 4 ½ minutes)

Adult: a team of 12 – 20 skaters. Skaters must be 21 years of age or older on July 1, and 75% must be 25 years of age or older on July 1. (Skating time: 3 ½ minutes)

Masters: a team of 8 – 20 skaters. Skaters must be 25 years of age or older on July 1, and 75% of the skaters must be 25 years of age or older on July 1. (Skating time: 3 minutes)

Adult Introductory: a team of 8 – 12 skaters. The majority of the team must be 19 years of age or older on July 1. (Skating time: 2 ½ minutes)

Collegiate: a team of 12 – 24 skaters. Skaters must be enrolled in a degree program as a full time student. Teams in this division must be sponsored by a college or university that has at least an Associate Membership with the U.S.F.S.A. The team must use the college or university's name as part of their name. (Skating time: 4 ½ minutes)

Collegiate Introductory: a team of 8 – 16 skaters. Skaters must be enrolled in a degree program at a college or university full or part time. (Skating time: 2 ½ minutes)
