From I-80 Westbound: West on I-80 to I-480 West exit 187. West on I-480 to I-480/I-271 North. North on I-480/I-271 to I-480 West exit 26B (Cleveland). West on I-480 to Lee Rd. exit 24. North (right) on Lee to South Miles Rd. East (right) on South Miles 1 mile to MetroPlex. Arena is on the north (left) side of the road.

From I-480 Eastbound: East on I-480 to Warrensville Center Rd. North exit 25A. North on Warrensville Center Rd. to South Miles Rd. (first road on the left). West (left) on South Miles ½mile to MetroPlex. Arena is on the north (right) side of the road.

Driving Instructions:

From I-80/I-90 (Ohio Turnpike) Eastbound: East on I-80/I-90 to I-80 East. East on I-80 to I-480 East (exit 9A). I-480 to I-71 North exit 11. (Sign says Cleveland/Columbus.) North on I-71 (becomes I-90). North on I-90 to Chester Ave./US-322 East exit 173B. East on Chester Ave./US 322 for 3 miles to Euclid Ave./US-20. North (left) on Euclid ½mile to Mayfield Rd. East (right) on Mayfield/US-322 for 2 miles to Monticello Blvd. North (left) on Monticello Blvd. to Cleveland Hts. Recreation Pavilion. Arena is on the left side of the road.

From I-80 Westbound (towards Cleveland): West on I-80 to I-480/Rt-14 West exit 13. West on I-480 to I-271 (I-480 merges onto I-271). North on I-271 to Wilson Mills Rd. exit 36. West on Wilson Mills Rd. (becomes Monticello Blvd.) to Monticello Blvd. approximately 5 miles to Cleveland Hts. Recreation Pavilion which is on the right side of the road.

From I-90 Westbound: West on I-90 to I-271 South. South on I-271 to Wilson Mills Rd. exit 36. West on Wilson Mills Rd. (becomes Monticello Blvd.) to Monticello Blvd. approximately 5 miles to Cleveland Hts. Recreation Pavilion which is on the right side of the road.

From I-90 Eastbound (from Cleveland): East on I-90 to Chester Ave./US-322 East exit 173B. East on Chester Ave./US-322 for 3 miles to Euclid Ave./US-20. North (left) on Euclid ½mile to Mayfield Rd. East (right) on Mayfield/US-322 for 2 miles to Monticello Blvd. North (left) on Monticello to Cleveland Hts. Recreation Pavilion. Arena is on the left side of the road.
