Regular season team entry fees: \$225.00 per Level A Team, \$225.00 per Level B Team, \$105 per Level C Team

Team entry fees must be paid in full by November 15, 2003. A \$25 late fee will be assessed for all late entries.

Individual District Competition

\$60.00 for 1st individual event, \$30.00 for 2nd individual event (LIMIT OF TWO INDIVIDUAL EVENTS).

Individual entry fees must be paid in full by December 15, 2003. A \$25 late fee will be assessed for all late entries.

State Championship Competition No charge

Test Levels:

Skaters must compete at their registered USFSA or ISI test level or one level higher as of November 15, 2003.

Team Scoring:

Teams will receive points for each event based on the number of teams competing with the first place team receiving the highest number of points and the last place team receiving one point. Points from each event at the three regular season team competitions will be totaled to determine the placement of teams for District awards and advancement to the State Championship. Points for each event will be totaled to determine awards for the State Championship. At the Individual District event and the State Championship, teams will receive points in the same manner based on the placement of skaters in each individual event. Points will be totaled for each team to determine the high point total awards.

Advancing to State Championship:

The top three teams from districts with 7 or more teams and the top two teams from districts with 6 or less teams for Level A and Level B will advance to the State Championship. Level C teams do not advance to the State Championship. The top two individuals from each event, from each district will advance to the State Championship. For individual events that require more than one flight, there will be a final round to determine the individuals who will advance to the State Championship. If any of the qualifying teams/individuals from a district withdraws, the next highest ranked team/individual will advance to the championship.

Awards:

<u>Regular Season Team Events</u> - First, Second and Third place medals will be awarded to the teams with the highest placement for each event for each level. Only skaters who participated in the event receive medals.

<u>District Team Awards</u> – At the conclusion of the final regular season team event, plaques will be awarded to the First, Second and Third place teams from each district for each level based on the accumulated point total from the three regular season events. First, Second and Third place District medals will be awarded to each member of these teams.

Individual District Events - First, Second and Third place District medals will be awarded to individuals with the highest placement for each event for each District. The team with the highest point total for each District will receive a team plaque. Championship Event - Championship medals will be awarded for each team and individual event the same as the regular season events. Trophies will be awarded to the First, Second and Third place teams for each level based on the accumulated point total from the team events. First Second and Third place Championship medals will be awarded to each member of these teams. Trophies will be awarded to the First place individual for each event and the team with the highest individual point total.

2003-2004 Michigan High School Figure Skating Team Competition Series Rules & Eligibility

- 1. The competition will be conducted in accordance with the rules as stated in the 2003-2004 USFSA Rulebook CR30.03 under "Special Competitions." This announcement will take precedence if there is a conflict with the USFSA Rulebook.
- 2. The team must be a U.S.F.S.A. School Affiliated Club (SAC). The SAC application is attached (form to be completed and returned to USFSA). Please submit a copy of the SAC application or SAC Certificate for proof of membership along with your application to competition chair.
- 3. Each team must have high school administrative or athletic department approval.
- 4. A team will consist of at least three skaters from one high school.
- 5. If a team of three cannot be fielded from one high school, high schools may combine as per MHSAA rules. All combined teams must be listed on the team application form.
- 6. If combined teams are not from the same school district, the following rules apply: An administrator from each school must sign the team entry form. All skaters from the combined schools must be allowed to skate on the team. Combined teams may not have more than one school with three or more skaters. Combined teams not adhering to these guidelines will be disqualified. The competition committee reserves the right to limit the number of schools that may combine to form a team.
- 7. The competition committee will grant final approval of a team's membership.
- 8. All skaters who enter must be in at least 9th grade and be enrolled as a student in the high school as per MHSAA rules.
- 9. All skaters must be registered with the USFSA or ISI in order to qualify for competition entry and provide their membership number on attached forms.
- 10. Each team member must be a member in good standing with the USFSA or ISI and their local member club.
- 11. A skater will not be allowed to participate unless they have a signed Skater Entry Form on file with the Registrar.
- 12. Skaters who change schools mid-season may not continue with the prior school, but may skate on the team for the new school.
- Males and females will skate on the same team.
- 14. Team or individual byes will not be granted for any competition including the State Championship as per MHSAA rules. Individual skaters must skate to be eligible for the Championship. If a skater is the only competitor at a given level, the skater must perform an exhibition to advance to the Championship. Except in the case of injury, a skater must have competed in at least one regular season team event in order to be eligible to skate in the team event at the State Championship.
- 15. The committee reserves the right to limit the number of entries, eliminate events due to insufficient entries, and combine or divide groups as necessary.
- 16. Late entries will be accepted at the discretion of the committee. A \$25 late fee will be assessed.
- 17. If a team does not have a skater capable of performing an element or eligible to perform an event, the team will receive no credit for that element or event.
- 18. If a team cannot participate at one of the district competitions, that team will receive no points for that competition.
- 19. Each participating team will need to provide a minimum of two volunteers and a food item for the individual and championship events.

Team Event Rules

- 1. Depending on the make-up of the team, a team may enter one or more levels. If there are not at least two Level C teams in any one district, no Level C events will be held in that district and skaters will be allowed to move up to Level B.
- 2. Skaters must compete at the appropriate level, or one level higher based on their USFSA or ISI freestyle and moves-in-the-field levels as of November 15, 2003 (ISI level equivalency on page one). Teams not adhering to the appropriate level restrictions will be disqualified for that event.
- 3. Skaters may only compete in one level and must remain at the same level for the entire season, including the State Championship, even If the skater tests beyond the level requirements during the season.
- 4. Each team will assign 1 to 4 skaters for Levels A and B to compete the four elements listed above for the Spins, Jumps and Moves events and 1 to 5 skaters for Level C to compete the five elements listed above. A skater may perform more than one element in each category, but teams are encouraged to remember that this is a team event and every effort should be made to include all team members. Only one skater per team may warm up each element.
- 5. Teams will be required to submit a Team Event Roster at check-in for each Team Competition. (Trial Basis)
- 6. At the start of each competition one of the team events will be randomly drawn and designated as the tiebreaker, to be disclosed and used only in the event of a team tie.
- 7. Each team will be allowed one retry per team per level (A, B, C) at Team Competitions. The second attempt has to be the exact same element as the first attempt by the same skater. The second attempt will count regardless of whether or not it was better than the first attempt. The coach would need to let the skater know in advance whether or not they should retry the element. The skater would signal for a retry immediately by raising their hand. The Referee would raise their hand in return in acknowledgement of the request for a retry. (Trial Basis)

The level a skater is entered for the Individual District Competition must be the same for the State Championship, if the skater advances, even If the skater tests beyond the level requirements during the season.

FREESTYLE EVENT

Skaters may not skate below their USFSA or ISI test level as of November 15, 2003, but may skate up one level higher (ISI level equivalency on page one). Program times include a range of times to allow skaters that wish to compete one level higher the flexibility to do so without having to use a different program for the High School Competitions.

- 1. Team entries will be accepted on a first come first serve basis.
- 2. Special consideration will be given to teams that need five competitions to meet varsity requirements.
- 3. Teams from outside of Michigan are welcome to participate. Out of state teams must submit a Skater Entry Form for each skater.
- 4. Unless otherwise noted, the same rules and regulations apply to this event as to the regular season.
- 5. Skaters may skate at the same level as the regular season, but are not required to as long as they qualify for the level they are entering. Skaters may only skate in one level per event.
- 6. Teams will be required to submit an Invitational Team Event Roster at check-in.
- 7. Points will not be counted toward the regular season and will apply to this event only.
- 8. First, second and third place medals will be awarded to the teams with the highest placement for each event.
- 9. Jumps/Spins/Moves team events will be the same as the regular season for Levels A and B. Level C elements will be the same as the regular season.
- 10. New Event! The longest element timed-only event.

Level A (Juvenile Freestyle and Above)

- Solo spin
- Combination spin (1 chg of foot only)
- Flying spin
- Ina Bauer or Spread Eagle (1 position only).

Level B (Pre-Juvenile Freestyle and Below)

- Solo spin
- Combination spin (1 chg of foot only)
- Back spin
- Forward Spiral (1 position only).

Elements will be skated in groups of up to 8 at a time. Each spinner will have a different timer. Spin timing will start with the first turn. Spirals, Ina Bauers and Spread Eagles timing will start with the position.

- Complete the application for School-Affiliated Club Membership (SAC) form and have it signed by the school administrator or athletic director. Send the SAC form to USFSA (address on form) along with the \$30.00 registration fee. Teams must submit this form and payment in order to participate (must be submitted every school year). Please submit a copy of the SAC application or SAC Certificate for proof of membership along with your application to competition chair.
- Teams intending to participate must contact the competition chair by September 30, 2003.
- Distribute copies of pages 1, 2, 3, 5, 6, and 7, plus copies of the Arena Maps to each individual skater.
- Determine which athlete will perform each element for each event for each level A, B and C, for each team competition. Complete the Team Event Roster for each Team Competition and turn it in at check-in.
- Make sure to allow athletes ample time to practice.
- Complete the Team Entry form for the season and have it signed by the school administrator(s) or athletic director(s). The Team Entry form, Skater Entry forms and and Team Roster forms need only to be submitted at the beginning of the season.
