## Certification by Athlete and Parent/Guardian & Authorization for Emergency Medical Treatment

Athlete/Parent/Guardian: I agree to conduct myself, both on and off the ice, in a manner that will reflect favorable upon this competition and upon the sport of figure skating, and that is consistent with the high standards of the sport. I agree to respect the person and property of others, and in the event I cause injury, damage, or loss to another or to the property of another, I hereby indemnify the USFS, the local Competition Committee, the Onyx-Suburban Skating Academy, and the Onyx-Rochester Ice Arena, their officers, directors, members, committees, representatives, employees, and agents, and to hold them harmless against any and all claims that another person may have or which may arise out of such injury, damage, or loss, together with any reasonable costs and attorney's fees that may be incurred as result of any such claims, whether valid or not.

I understand that USFS and the Onyx-Suburban Skating Academy or organizers of this competition undertake no responsibility for damages or injuries, or loss of property suffered by the competitors. As a condition of and in consideration of the acceptance of their entries or participation therein, all entrants, their parents and guardians and officials shall be deemed to agree to assume all risks of injury to their person and property resulting from, caused by or connected with, the conduct and management of the competition, and to waive and release any and all claims which they may have against any officials, USFS, organizers of the competition, the Onyx-Suburban Skating Academy and its officers, and their entries shall be accepted only on such condition (Rule 3222).
