

2010 Traverse City Cherry Classic Figure Skating Competition Practice Ice Schedule

The following practice ice schedule will be available for Friday and Saturday at Centre Ice Arena. No music will be played on practice ice (except dance music during the ice dance practices). No props allowed on practice ice. The cost is **\$12.00 per session**. Practice ice is available by advance reservation with payment and must be **postmarked by May 25**. **Applications will be processed on a postmark basis and should be submitted quickly**. No practice ice will be assigned without payment. Unfilled spaces may be purchased on-site at the time of arrival on a first-come, first-served basis.

- **Basic Skills session** is for basic skills skaters only; Basic Skills skaters may only practice on basic skills sessions
- **General sessions** are open to beginner through senior. All other sessions are designated by FS level
